## VENDOR SETUP

All Vendors must set up on THURSDAY, JULY 17, 2008 BY 8 PM. There will be no extra charge Thursday for set up. Vendors must be completely vacated by 6:00 pm on Sunday, July 20.

## INSURANCE

**Certificate of Insurance must be submitted with this application OR a \$30 per day insurance fee is to be paid to the Hayfork-N-You Rally Office on Thursday, July 17. All vendors must provide insurance when renting buildings or areas at the Trinity County Fairgrounds. Insurance can be purchased through Hayfork-N-You Motorcycle Rally and Trinity County Fair, or if you are already insured then a copy of your insurance certificate listing Hayfork-N-You Motorcycle Rally and Trinity County Fair Association as additional insured is required and must be \$1,000,000.00 liability.**

**The following wording MUST appear as written on insurance certificates provided:**

**ADDITIONAL INSURED - That the State of California, Trinity County Fair Association, the County of Trinity and Hayfork-N-You Motorcycle Rally, their agents, directors, officers, servants and employees are made additional insured, but only insofar as the operations under this contract are concerned.**

## HOLD HARMLESS

Vendors agree to indemnify and hold harmless the Hayfork-N-You Rally committee, its officers, agents and employees from any and all claims, causes of action and suits occurring or resulting from any damage, injury or loss to any person or persons, including but not limited to loss of property, goods, wares or merchandise, caused by, arising out of, or in anyway connected with the exercise by the vendor of the privileges herein granted.

## LIABILITY AND SECURITY

The Hayfork-N-You Rally Committee, its Board of Directors and its staff will not be responsible for losses of any kind, whether by fire, theft, physical violence, elements of nature or any other cause, however originating. The Rally will provide minimal security for the three-day event; however, participants are responsible for their own merchandise and equipment, its protection and insurance.

## ADDITIONAL TERMS AND CONDITIONS:

1. No drug paraphernalia to be displayed or sold.
2. No firearms to be displayed or sold.
3. Nothing containing alcohol to be displayed or sold.
4. All pepper sprays are to be in sealed packages Vendors Permit & County Health Dept. permit.
5. No drinking of alcohol in your booth (if applicable).
6. If its illegal you cannot sell it.
7. All subletting subject to permit and fee requirement.
